

Chesapeake Construction Education Apprenticeship Trust (CCEAT)
2011 Chevy Truck Raffle Official Rules



1. The raffle is open to persons 18 years and older living in the United States.
2. The purchase price for each ticket is \$150.00. Payment may be made by Visa or MasterCard, cash, check or money order. Checks or money orders should be made payable to CCEAT. Checks and money orders will be deposited upon receipt. If a bank returns a check, the entry will be declared invalid unless and until full payment plus a \$25 bank return charge is received. Full payment must be received prior to deadline date of Friday, December 9, 2011 – OR – until all tickets are sold.
3. Completed entries and funds must be in the possession of CCEAT before the drawing on Friday, December 9, 2011 or when 400 tickets are sold, whichever is sooner, in order to be eligible for the drawing. Any funds received after 400 tickets are sold or the closing date will be returned uncashed.
4. The raffle will run from Thursday, January 27, 2011 to Friday, December 9, 2011 or as long as supplies last.
5. A maximum of 400 tickets will be sold.
6. Three winning tickets will be drawn. The three prizes will be as follows:
 - 1st Prize –2011 Chevy Silverado 1500 LT Truck as configured by CCEAT – OR – a vehicle of winner’s choice valued at \$25,000
 - 2nd Prize - \$2,500 cash
 - 3rd Prize - \$1,000 cash
7. 1st prize vehicle will be provided by ABC Chesapeake Shores member - Courtesy Chevrolet of Salisbury.
8. One winning ticket for each of the three prizes will be drawn by random drawing on Friday, December 9, 2011 during the ABC Chesapeake Shores Annual Holiday Gala – OR – at an ABC Chesapeake Shores general membership event once all tickets are sold, whichever date is sooner.
9. Winners need not to be present to win. Winners will be notified immediately after the drawing by phone. Winners will also be announced on our website: www.abc-chesapeake.org. 10. Winners may be required to produce a ticket with a corresponding number to the ticket stub drawn as well as two forms of identification and a social security number.
11. The ABC Chesapeake Shores member or staff personnel noted as the seller on the winning first place raffle ticket will receive a \$1,000 selling bonus from CCEAT. In the event that no seller is indicated, CCEAT will retain the \$1,000 bonus.
12. Winners agree to allow CCEAT to use their names, photos and images for the use of promoting and marketing this raffle and subsequent raffles, including publishing the winner’s photograph on ABC’s website. Winners’ names will be available to the media.
13. CCEAT is a 501(c)(3) not-for-profit entity. Donations and contributions are tax deductible to the legal extent of the law under IRS regulations.
14. Members of the general public as well as employees of ABC and their immediate families (defined as employees’ children, spouse or parents) are eligible to participate.
